Guideline Search Strategy

1. Structured Website Search

Two Guideline Development Methodologists searched an established list of website for guidelines. Guidelines were selected based on the following criteria:

- Guideline in English
- Available and accessible for retrieval
- Developed based on a systematic search of the literature
- Contains a description of how the recommendations were developed
- Includes the word guideline or recommendation in the title or description
- Guideline was dated no earlier than January 2013
- Relevant to nursing practice
- Applicable to the Canadian context (e.g., applicable to the Canadian context (e.g.-studies in countries with similar culture and economic status/developed nations such as OECD countries http://www.oecd.org/about/membersandpartners/)
- Guideline was focused on the topic area (Vascular Access)
- All ages (pediatrics and adults)
