# Jan. 1, 2011

Remove prescription lists under the Nursing Act, 1991

### June 1, 2011

Laboratory and diagnostic tests ordered by NPs to be covered as an insured service under the Health Insurance Act, 1990

# July 1, 2011

Remove limitations of NPs to order laboratory tests according to a prescribed list under the Laboratory and Specimen Collection Centre Licensing Act

Complete a Medical Certificate of Death in hospital under the Vital Statistics Act, 1990

Ability to treat, transfer and discharge from hospital under the Public Hospitals Act, 1990

#### Oct. 1, 2011

Ability to: set or cast a fracture of a bone or dislocation of a joint; dispense, sell, compound or broadly prescribe drugs; and apply a prescribed form of energy under the Regulated Health Professions Act. 1991

Authorize RNs and RPNs to accept care from an NP and remove laboratory lists under the Nursing Act, 1991

#### 1971

Ontario's first education program for an expanded RN role is launched at the University of Toronto

#### 1995

The Ontario Primary Health Care NP (PHCNP) program is launched by the Council of Ontario University Programs in Nursing (COUPN) and offered in nine universities

# Feb. 18, 1998

Bill 127 recognizes NPs, officially called "RNs in the Extended Class"

#### 2007

NP becomes a protected title in Ontario under the Health Systems Improvement Act, 2007

# May 2009

NPs enroll in Canada's first Anesthesia Care Program at the University of Toronto

### Yearly

Pre-budget submission submitted to government annually to advocate for expansion of practice, funding and integration of NPs into the health system

#### June 2006

The Canadian NP Initiative (CNPI) is created to support Canada-wide efforts to integrate the NP role

#### 2007

Integration of NPs into Ontario from the Nurse Practitioner Integration Task Force Team

# Scope of practice expansion

#### May 1, 2015

Enable NPs to refer directly to specialist care under the Health Insurance Act and the Schedule of Benefits for Physician Services

### **April 19, 2017**

NPs authorized to prescribe controlled drugs and substances under changes to the Controlled Drugs and Substances Act and the Nursing Act. 1991

#### 2018

NPs authorized to prescribe high dose pain killers for palliative patients and prescribe/administer methadone under changes made to the Controlled Drugs and Substances Act, 1996

# July 1, 2022

Perform point-of-care tests, and order CT and MRI scans under the Healing Arts Radiation Protection Act, 1990, the Regulated Health Professions Act, 1991 and the Laboratory and Specimen Collection Centre Licensing Act

# Nov. 29, 2023

NPs authorized to prescribe and possess anabolic steroids other than testosterone under changes made to the Controlled Drugs and Substances Act, 1996

# July 1, 2012

NPs gain ability to admit to hospital; hospital chief nursing executives (CNE) made members of hospital boards

# 2014

Funding for 75 Attending NPs in long-term care homes

#### 2016

Liberal government announces additional funding to retain and recruit NPs into primary care

#### Oct. 2, 2022

Funding for an additional 225 Attending NPs in long-term care homes

#### 2022

Major insurance carriers to accept patient claims from NPs

#### Nov. 20, 2023

Funding for an additional 121 student NP seats

#### May 3, 2024

Midwives may now access medications through a NP
