GUIDELINES

- Nominations must be received no later than **1700 hours on Monday, December 8, 2014**
- All nominations should be sent to Penny Lamanna at: plamanna@RNAO.ca on behalf of the Chair, Provincial Nominations Committee; by fax to 416-599-1926; or by regular mail to:

- Candidate nominated **must be an RNAO member in good standing for the 2015 membership year**, who is willing to carry out the obligations of the office to which she/he may be elected
- Candidates must have maintained a regular RNAO membership* for a minimum of two (2) consecutive years preceding his or her nomination (*RN)
- Candidates (nominees) require the signatures of **three** nominators who **must** be RNAO members in good standing for the year 2015
- **Regional Representative:** In accordance with RNAO Policy 6.04(1)(c) Candidates shall be nominated by three nominators; and at least **one** of the nominators shall be a member of the applicable region [*to be represented by such regional representative*]. Past experience and involvement is beneficial (e.g. active chapter or interest group executive member)
- **President-Elect:** Demonstrated leadership is preferred, or an asset. Candidates for this position must provide a brief (one page) letter of support from each of three nominators, outlining why the candidate is suitable for this office. Also:
 - Mandatory for President-Elect candidates: Provide a video clip - 3 min maximum, to be shared online with all RNAO members during the One Member One Vote (March-April 2015)
- Members can run for only one (1) position in the elections
- SHOULD YOU LET YOUR NAME STAND, THEN WITHDRAW, your name will - once approved by the Provincial Nominations Committee - remain on Ticket of Nominations, subject to announcement to members
- All nominations should include a short biography of the candidate of **not more than 250 words** which covers the two categories (i) education/experience and (ii) philosophy (*please do not forward a CV*)
- Nominations should include a head and shoulders photograph of each candidate. Please attach the photo to an email* as a **jpg** file (*can be sent at a later date, if not presently available)

Both pages of this nomination form must be correctly completed to nominate a candidate to one of the above-noted vacant director positions, in accordance with RNAO Policy 6.04.

RNAO Board committees: Candidates are also sought for the following vacancies:

- Member, Provincial Nominations Committee (RN vacancies)
- Member, Provincial Resolutions Committee (RN vacancies)
- Member, Bylaws Committee (RN vacancies)
