

## Election Ontario 2007 Comparison of Four Major Political Party Platforms

Explanatory Note: The following table lists RNAO's key expectations for the next government and compares the four major Ontario political parties' positions on these issues. The table is based on the platforms and costings available from the four party websites.<sup>1</sup> Only those commitments that address demands in RNAO's own platform were included. Numbers in brackets indicate the platform page on which the commitment is made; when the source is a costing document, it the reference appears in the following form: (c. 7) to indicate page 7. Unless otherwise specified, expenditure commitments are annual levels that would be reached after four years. The NDP is not releasing its platform all at once, so only those promises that appear as Commitments on the NDP website are included. The NDP portion of this platform comparison will be updated as the NDP platform is released.
